The undersigned (on our behalf and on the behalf of our heirs, personal representatives, successors and assigns), for and in consideration of the opportunity to participate in the CENTURY MEMORIAL RIDE, hereby releases ALL CENTURY DEPUTY SHERIFFS, ALL SPONSORS and other participants on this motorcycle ride from any and all claims and demands, rights and causes of action of any kind whatsoever which I now have or later may have resulting from, arising out of, or in connection with my participation in this ride.

This release extends to any and all claims I have, or may have against the released parties whether such claims result from negligence (except willful neglect) on the part of any and all released parties with respect to this event or with respect to the conditions, qualifications, instructions or Procedures under which this event is conducted or from any other cause. I understand that this means that I agree not to sue any or all of the released parties for any injuries resulting to myself or my property during or in connection with this event.

For the purposes of implementing this release, I expressly acknowledge that this release is intended to include all claims which the parties do not know or suspect exist in their favor at the time of the execution hereof, including specifically, without limitation, those described in section 1542 of the California Civil Code, which section reads as follows:

“A general release does not extend to claims which the creditor does not know or suspect exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor.”
